We plan to make a collective complaint at the European Committee of Social Rights on the French laws No. 2010-1127 of 28 September 2010 to fight against school absenteeism (JORF No. 0226 of 29 September 2010 page 17553 Text # 1) and law No. 2011-267 of 14 March 2011 on the parental responsibility contract. These laws designed the suspension of family allowances in cases of truancy of their children.. This law is discriminatory and violates the economic and social We need your evidence on the impact that this legislation has on the lives of all, the lives of families and social workers who are also parents. It is also a great opportunity to show that social workers and users can be on the same side of the barricade, and promote a citizen participation!

Lanzarote Convention (2007)

The new Convention of the Council of Europe on the protection of children against sexual exploitation and sexual abuse was signed by 25 countries and ratified by 18 including France

Following this, the EU has developed in 2011 a directive to combat sexual abuse and sexual exploitation against children (Decision 2004/68/JHA). Both documents modify the current field of child protection. http://www.coe.int/t/dg3/children/1in5/OurCampaign/objectives_fr.asp

Monitoring the implementation of the Convention in the country is provided by the committee of the parties composed on governments and civil society (Conference of INGOs, European institutions). Every country that has ratified the Convention will inform the Committee on the progress and obstacles.

The convention of Lanzarote is an important pillar of the NEW STRATEGY (2012-2015) of the Council of Europe ON THE RIGHTS OF CHILDREN.

In 2011 the Committee of Ministers adopted the new Recommendation CM / Rec (2011) 12 on child rights and social services appropriate to children and families.

This recommendation refers, among others, to the recommendation on positive parenting and strengthening parenting skills.

Children's participation should be considered not only as to develop the capacity of the child - that is to say what he will become in the future - but also in terms of current quality of life of the child . This participation can take many forms and have consultative nature or collaborative or come as an initiative from the child. It seems important to note that these forms of participation do not involve the same degree of child responsibility!
